The commission shall not be paid to the AIN holder if the Switch transaction does not happen, or fresh UIN is not provided within 30 days. The commission may be paid if the fresh UIN is provided by investor within 30 days.

- If the Name given in the application does not match the name as appearing on the PAN Card/Household card, authentication, application may be liable to get rejected or further transactions may be liable to get rejected.

II. AFFILIATE INFORMATION

- Name should be given in full without any abbreviations. Preferably write exactly as it appears in your Bank Account or as it appears in the incorporation document as the case may be.
- Guardian name and date of birth of the Minor is mandatory for investment on behalf of minor applicant. Age proof of minor is mandatory. Upon obtaining majority a minor has to write to the fund giving his specimen signature duly authenticated by his banker as well as his new bank mandates, PAN details, etc. in order to facilitate the Fund to update its records and permit the erstwhile minor to operate the account in his own right.
- Name of the Contact Person, Email and Telephone no. should be mentioned in case of investments by Company/Body Corporate, Trust, Society, FII and other non-individual applicants.
- Applicant should specify the mode of holding, in case it is not mentioned, the default will be "anyone or survivor".
- In case of FII investment, complete postal address should be stated. P.O. Box address alone is not sufficient. Mails/Note should necessarily state their overseas address falling which application may be rejected. In addition, Indian address should be stated for correspondence.
- In help as service you better please provide email id and mobile number.
- In case of Minor investor proper third party declaration should be submitted by donor.

III. BANK DETAILS

Applicants are requested to mention the bank account, since the same is mandatory as per the directions issued by SEBI. Application without this information will be deemed to be incomplete and are liable for rejection. Investor should submit a copy of a cancelled cheque to verify details.

IV. INVESTMENT DETAILS

Investors should indicate the Plan/Option for which the application is made. In case investor wish to choose both the Options, separate Application form will have to be filled. In case applications are received where Plan/Option/Sub-option frequency is not selected the default options will be considered.

V. PAYMENTS

Any odd lot after division shall be assigned / transferred to the first nominee mentioned in the form.
- In case of demise of the investor and any one of the nominees, the regulated entities shall distribute the assets pro-rata to the remaining nominees.

VII. ACCEPTANCE OF FINANCIAL TRANSACTIONS THROUGH EMAIL IN RESPECT OF NON-INDIVIDUAL INVESTOR

For acceptance of financial transactions in respect of non-individual investors received through email, (NFI) may review that the process is in place at their end (FCI as may be applicable)

1. Obtain from the entity a copy of the latest resolution or an authority letter or the entity's letter head, granting appropriate authority to the designated affiliate of the entity. The board resolution/ authority letter shall explicitly mention the following:

(i) List of approved authorised affiliate who are authorised to transact on behalf of non-individual investors along with their designation and email ID.

(ii) An undertaking that the instructions for any financial transactions sent by email by the authorised affiliate shall be binding upon the entity as if it were a written agreement.

2. In case the document is executed electronically with a valid Digital Signature Certificate (DSC) or through Aadhar based signature by the authorised affiliate(s), the same shall be considered as valid and acceptable, and shall be binding on the non-individual investor even if the transaction request is not received from the registered email id of the authorised affiliate(s). However, in such cases, the domain name of the email ID should be from the same organisation's official domain name.

3. In addition to the acceptance of financial transactions via email, scanned copy of duly signed transaction form/request letter bearing wet signatures of the authorised signatories of the entity, received from same other official / employee of the non-individual investor may also be accepted, and shall be binding on the non-individual investor provided

(i) The email is also CC'd (copied) to the registered email ID of the authorised affiliate / signatory of the non-individual unit holder; and

(ii) the domain name of the email ID of the sender of the email is from the same organisation's official domain name.

4. In addition to the acceptance of financial transactions via email,

(a) scanned copies of signed transaction form/request letter bearing wet signatures of the authorised signatories of the entity, received from the registered mutual fund distributor of the entity or a third party duly authorised by the non-individual unit holder may also be accepted subject to fulfillment of the following requirements:

(i) Authorisation letter from the non-individual unit holder authorising the MFD/person to send the scanned copies of signed transaction form/request letter on behalf the non-individual investor.

(ii) In such cases, the non-individual unit holder's registered email ID shall also be copied in the email sent by the MFD/person sending the scanned copies of the duly signed transaction form/request letter to the letter as the case may be, after following the prescribed procedure.

VIII. DECLARATION AND SIGNATURES

1. Signatures can be in English or in any Indian language. Thumb Impressions must be attested by a Magistrate/Notary Public under his/her official seal. In case of HUF, the Karta will sign on behalf of the HUF. Similarly, for the Association of Persons (AOP) the application must be signed by the Authorised Signatory. Applications on behalf of minors should be signed by their Guardian.

2. If the application form is signed by a Power of Attorney (POA) holder, the form should be accompanied by a notarised photocopy of the POA. Alternatively, the original POA can be submitted, which will be returned after verification. The signature of the investor and the POA holder has to be clearly captured in the POA document to be accepted as a valid document.

3. In case of corporate or any non-individual investors, a list of authorised signatories should be submitted along with the application form.

II. EMAIL COMMUNICATION

Deposit Statements / Statements / Annual Reports / Other statutory information (as may be permitted under SEI (Mutual Funds) Regulations, 2002) can be sent to each unit holder by e-mail (postment). Unit holders who have opted to receive these documents by email will be sent all documents by email only and no physical documents will be sent. Should the Unit holder experience any difficulty in accessing the electronically delivered documents, the Unit holder may request the Fund for delivery of the same through alternate means. It is deemed that the Unit holder is aware of the security risks including possible third party interception of the documents. Default option is email for CDD and holding statements on 7 August 21, 2023.

II.1. EMAILING

This facility enables the Unit holder to receive CDD confirmation for purchase, redemption, switch, distribution.

II.2. CDDT FILL

In compliance with Paragraph 3.4 of SEI: Master Circular on Mutual Funds dated March 20, 2023, in all the eligible schemes of Navi Mutual Fund along with the 'Regular Plan'. The Direct Plan is only for investors who purchase (subscribe) Units in a Scheme directly with the Fund and is not available for investors who route their investments through a Distributor / All Plans / Options / Sub-Options offered under the Scheme of 'Indirect Plan' will also be available for subscription under the "Direct Plan". For details please refer to the facts or Scheme options. Accordingly, investors subscribing under Direct Plan of Navi Nifty REITs & Realty Index Fund have to indicate the Scheme / Plan name in the application form as 'Navi Nifty REITs & Realty Index Fund - Direct Plan'. Investors should also indicate "Direct" in the AXX column. In case Distributor sale is mentioned in the application form, the Distributor sale will be ignored and no commission will be paid to the distributor. Direct Plan shall have a lower expense ratio including distribution expenses, commission, etc. and no commission for distribution of Units will be paid / charged under Direct Plan.

II.3. UNIT HOLDER VERIFICATION (AML) REGULATIONS

Circle for compliance with Anti Money Laundering (AML) regulations. Prevention of Money Laundering Act, the SEI Circular on Anti Money Laundering and the Client Identification Implementation procedures prescribed by AMLF Inter-Cell require the AMC to verify the records of identity and addresses of investors. Applications without such documents and information may be rejected. Uniform KYC Norms of SEI: Master Circular on Know Your Client (KYC) norms for the securities market dated October 12, 2023. Permanent Account Number (PAN) must be the sole identification number for all participants transacting in the securities market. Irrespective of the amount of transaction, except (a) investors residing in the state of India (b) Central Government, State Government, and the officials appointed by the courts (c) Official Declaration Court resident (d) under the category of (Bankrupt), and (e) investors participating in inter-deposit, in compliance with Clause 3.3.7 of SEI: Master Circular of Mutual Fund dated May 28, 2023, has exempted that Domestic Investment Plans (DIP) and Lumpsum Investments (both put together) per mutual fund up to Rs. 20,000/- per year per investor shall be exempted from the requirements of PAN. Accordingly, investments in Navi AMC CDD (including DIP Investments where the aggregate of DIP Investments in a rolling 12 months period or in a financial year (i.e. April to March) of up to Rs. 20,000/- per investor per year shall be exempted from the requirement of PAN. However, eligible investors (including joint holders) should comply with the KYC requirement through registered CDD by submitting photo identification documents as proof of identification and the Proof of Address (self/declared by the investor / affirmed by the AMLN holder/AMLN distributor). These exempted investors will have to quote the "PBOA" (PAN exempt KYC for No) in the application form. The AMC reserves the right to reject subsequent requests in the absence of appropriate compliance with the AML laws, as amended by SEI from time to time.

III. BULK

Investments through distributors

In pursuance of Securities and Exchange Board of India (SEBI), the distributors, agents or any persons employed or engaged or to be employed or engaged in the sale and/or distribution of mutual fund products are required to have a valid certification from the National Institute of Securities Markets (NISAM) by passing the certification examination. Further, no agents / distributors are entitled to sell units of mutual funds unless the intermediary is registered with Securities of Mutual Funds in India (AMFI). Employer Unique Identification Number (EIN) SEI has made it compulsory for every employee / relationship manager / sales person of the distributor of mutual fund products to quote the EIN obtained by him/her from AMFI in the Application Form. EIN is particularly in subsidiary transactions, could assist in addressing any issues of mis-selling even if the employee/relationship manager / sales person later leaves the employment of the distributor. Individual KYC holders, including senior citizens distributing mutual fund products are also required to obtain and quote EIN in the Application Form. Hence, if your investments are routed through a distributor, please ensure that the EIN is correctly filled up in the Application Form. However, if your distributor has not given you any advice pertaining to the investments, the EIN is not may be left blank. In this case, you are required to provide a duly signed declaration to this effect, as given in the form. Chennai Distributors Database: Distributors are exempt from obtaining NISAM certification and AMFI registration. However, such Chennai Distributors are required to comply with the guidelines / requirements as may be issued by SEI / NISAM from time to time and also comply with the laws, rules and regulations of jurisdictions where they carry out their operations in the capacity of distributors. Direct Investments: Investors applying under Direct Plan must mention "Direct" in AXX column. In case Distributor sale is mentioned in the application form, but "Direct Plan" is indicated against the Scheme name, the Distributor sale will be ignored and the application will be processed under Direct Plan. In case of valid application received with an indicating "Direct Plan" against the Scheme / Plan name and without any Distributor sale mentioned in the form, the application will be processed under "Direct Plan".

IV. WITHHOLDING INFORMATION

1. Deposit Statement

The AMC shall send an statement confirmation specifying the units allotted by way of email and/or CDD within 2 Business days of receipt of valid application/transaction to the Unit holder (registered email address and / or mobile number (wherein units are held in demat mode or in account statement form)).

2. Consolidated Account Statement and Monthly CDD shall be issued to investors that have opted for delivery via electronic mode (e-CDD) by the twelfth (12th) day from the month end, detailing all the transactions across all schemes of Navi Mutual Fund and to investors that have opted for delivery via physical mode by the fifteenth (15th) day from the month end.

The CDD will be dispatched by email to all the investors whose email addresses are registered with the Depositories and CDDs/MP-ETDs. However, where an investor does not wish to receive CDD through email, applicant shall be given to the investor to receive the CDD in physical form at the address registered with the Depositories and the CDDs/MP-ETDs. The depositories shall also inform the investor on quarterly basis through the CDD mode specifying the email to which the CDD is being sent.

If there is any transaction in any of the demat accounts of the investor or in any of his mutual fund folios, then CDD shall be sent to that investor through email on a monthly basis. In case there is no transaction in any of the mutual fund and demat accounts then CDD with holding details shall be sent to the investors by email on half yearly basis. The depositories shall dispatch the CDD to investors that have opted for delivery via electronic mode, on or before the eighteenth (18th) day of April and October and to investors that have opted for delivery via physical mode, on or before the twenty-first (21st) day of April and October.

However, where an investor does not wish to receive CDD through email, applicant shall be given to the investor to receive the CDD in physical form at the address registered with the Depositories and the CDDs/MP-ETDs. In the event the investor has more than one registered holder, the first named Unit holder shall receive the CDD / account statement.

The transactions viz. purchase/redemption/switch, etc., carried out by the Unit holder shall be reflected in the CDD on the basis of Permanent Account Number (PAN).

The CDD shall not be received by the Unit holder for the folio(s) not updated with PAN details. The Unit holder are therefore requested to ensure that the folio(s) are updated with their PAN.

In case of a specific request received from the Unit holder, the AMC will provide an account statement (reflecting transactions of the Fund) to the investors within 2 Business Days from the receipt of such request, by mail/email. The Unit holder without any charges may request for a physical account statement by writing requesting the AMC/CKYR. The Mutual Fund/AMC shall dispatch an account statement within 2 Business Days from the date of the receipt of request from the Unit holder.

Half Yearly CDD will be issued to investors that have opted for e-CDD on or before the eighteenth (18th) day of April and October, to all investors providing the prescribed details across all schemes of mutual funds and to investors that have opted for delivery via physical mode by the twenty first (21st) day of April and October.

The placement of holding of the beneficiary account holder for units held in demat will be done by the respective DPs periodically.

The Deposit Statement shall state that the net investment is gross subscription less transaction charges, if any and specify the no. of units allotted against the net investment.

CDD for investors having Demat accounts

- Investors having MF Investments and holding securities in Demat accounts shall receive a single Consolidated Account Statement (CAS) from the Depository.
- Consolidation of account statements shall be done on the basis of Permanent Account Number (PAN). In case of multiple holding, it shall be PAN of the first holder and pattern of holding. The CDD shall be generated on a monthly basis.
- If there is any transaction in any of the Demat accounts of the investor or in any of his mutual fund folios, depositories shall send the CDD within ten days from the month end. In case, there is no transaction in any of the mutual fund folios and demat accounts then CDD with holding details shall be sent to the investor on a half yearly basis.
- In case an investor has multiple accounts across two depositories, the depository with whom the account has been opened earlier will be the default depository.
- No Demat Statements will be issued by the AMC to Unit holders who hold units in dematerialised mode.

3. Annual report

- The scheme's annual report, in machine readable format, shall be hosted on the website of the AMC at <https://navi.com/mutual-fund/disclosure/statutorydisclosure> and on the website of AMFI at <https://www.navimutualfunds.com>. The AMC shall display the link prominently on their website and make the physical copies available to the unit holders, at their registered office at all times.
- AMCs shall send an email/SMS to all unit holders regarding the timing of scheme's annual report on their website and on the website of AMFI.

AMCs shall email the scheme annual report or abridged summary thereof, in machine readable format, to all such unit holders, whose email addresses are registered with the Mutual Fund, within 6 months from the date of closure of the relevant financial year. 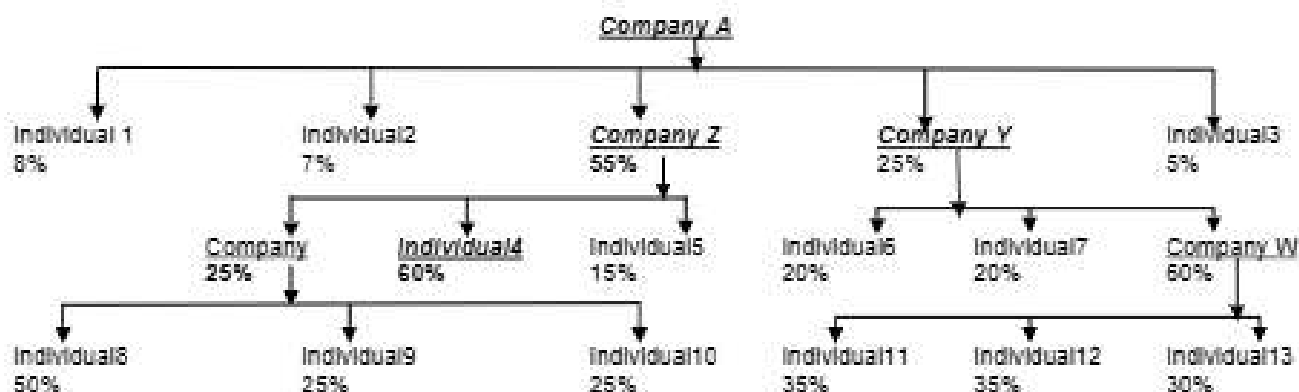

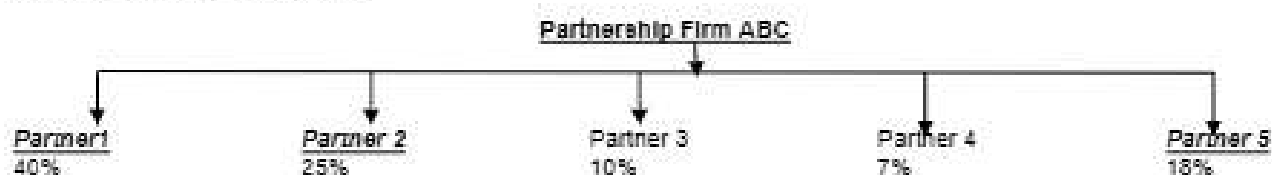

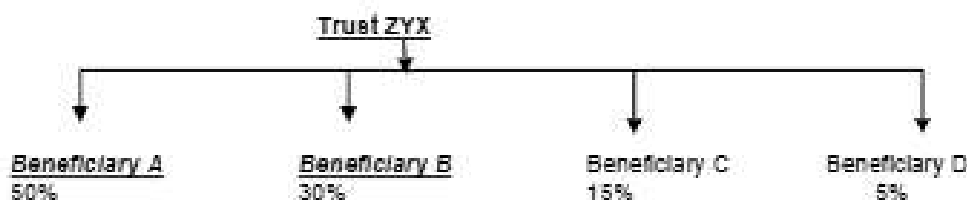

IMPORTANT INFORMATION & INSTRUCTIONS FOR ASBA MUTUAL FUND INVESTORS

Background : In its continuing endeavour to make the existing public issue process more efficient SEBI introduced a supplementary process of applying in public issues, viz. the "Applications Supported by Blocked Amount (ASBA)" process. Accordingly, Securities and Exchange Board of India (Issue of Capital and Disclosure Requirements) Regulations, 2009, as have been amended for ASBA process, in compliance with Clause 15.10 of SEBI Master Circular on Mutual Funds dated March 30, 2026, for "Additional mode of payment through Applications Supported by Blocked Amount (hereinafter referred to as "ASBA") are mentioned below for understanding the ASBA process

1. Meaning of ASBA: ASBA is an application for subscribing to a New Fund Offer Application Form (NFO), containing an authorisation to block the application money in a bank account.

2. Self-Certified Syndicate Bank (SCSB): SCSB is a banker to an issue registered with the SEBI which offers the facility of applying through the ASBA process. The list of SCSBs will be displayed by SEBI on its website at www.sebi.gov.in from time to time. ASBAs can be accepted only by SCSBs, whose names appear in the list of SCSBs displayed on SEBI's website. As on April 15, 2010, 27 Banks have been recognised as SCSBs. Investors maintaining their accounts in any of these Banks may approach one of the designated branches of these SCSBs for availing this facility. Further it may be noted that from time to time new banks register themselves as SCSBs who become eligible to provide these services and also the existing SCSBs designate additional branches that also provide this facility. An updated list of all the registered SCSBs, their controlling branches, contact details and details of their contact persons, a list of their designated branches which are providing such services is available on the website of SEBI at the address <http://www.sebi.gov.in>. Further these details are also available on the website of the Stock Exchanges at <http://www.bseindia.com> and <http://www.nseindia.com>. Alternatively, investors may also contact the AMC, R&TA for information about the SCSBs or the ASBA process. These SCSBs are deemed to have entered into an agreement with the issuer and shall be required to offer the ASBA facility to all its account holders for all issues to which ASBA process is applicable. A SCSB shall identify its Designated Branches (DBs) at which an ASBA bidder shall submit ASBA and shall also identify the Controlling Branch (CB), which shall act as a coordinating branch for the Registrar to the issue, Stock Exchanges and Merchant Bankers. The SCSB, its DBs and CB shall continue to act as such, for all issues to which ASBA process is applicable. The SCSB may identify new DBs for the purpose of ASBA process and intimate details of the same to SEBI, after which SEBI will add the DB to the list of SCSBs maintained by it. The SCSB shall communicate the following details to Stock Exchanges for making it available on their respective websites. These details shall also be made available by the SCSB on its website: (i) Name and address of the SCSB (ii) Addresses of DBs and CB and other details such as telephone number, fax number and e-mail ids, (iii) Name and contact details of a nodal officer at a senior level from the CB.

3. Eligibility of Investors: An investor shall be eligible to apply through ASBA process, if he/she: (i) is a "Resident Retail Individual Investor, Non Institutional Investor, QIBs, Eligible NRIs applying on nonrepatriation basis, Eligible NREs applying on repatriation basis i.e. any investor, (ii) is applying through blocking of funds in a bank account with the SCSB. Such investors are hereinafter referred as "ASBA Investors".

4. ASBA Facility in Brief: Investor shall submit his Bid through an ASBA cum Application Form, either in physical or electronic mode, to the SCSB with whom the bank account of the ASBA investor or bank account utilized by the ASBA investor ("ASBA Account") is maintained. The SCSB shall block an amount equal to the NFO application Amount in the bank account specified in the ASBA cum Application

Form, physical or electronic, on the basis of an authorisation to this effect given by the account holder at the time of submitting the Application. The Bid Amount shall remain blocked in the aforesaid ASBA Account until the Allotment in the New Fund Offer and consequent transfer of the Application Amount against the allocated Units to the issuer's account designated for this purpose, or until withdrawal/rejection of the Offer or until withdrawal/rejection of the ASBA Application, as the case may be. The ASBA data shall thereafter be uploaded by the SCSB in the electronic IPO system of the Stock Exchanges. Once the Allotment is finalised, the R&TA to the NFO shall send an appropriate request to the Controlling Branch of the SCSB for unblocking the relevant bank accounts and for transferring the amount allocable to the successful ASBA Bidders to the AMC account designated for this purpose. In case of withdrawal/ Rejection of the Offer, the R&TA to the Offer shall notify the SCSBs to unblock the blocked amount of the ASBA Bidders within one day from the day of receipt of such notification.

5. Obligations of the AMC: AMC shall ensure that adequate arrangements are made by the R&TA for the NFO to obtain information about all ASBAs and to treat these applications similar to non-ASBA applications while allotment of Units, as per the procedure specified in the Securities and Exchange Board of India (Issue of Capital and Disclosure Requirements) Regulations, 2009. Investors are requested to check with their respective banks about the availability of the ASBA facility.

Other information for ASBA investors:

- SCSB shall not accept any ASBA after the closing time of acceptance on the last day of the NFO period.
- SCSB shall give ASBA investors an acknowledgment for the receipt of ASBAs.
- SCSB shall not upload any ASBA in the electronic system of the Stock Exchange(s) unless (i) it has received the ASBA in a physical or electronic form; and (ii) it has blocked the application money in the bank account specified in the ASBA or has systems in place to ensure that Electronic ASBAs are accepted in the system only after blocking of application money in the relevant bank account opened with it.
- SCSB shall ensure that complaints of ASBA investors arising out of errors or delay in capturing of data, blocking or unblocking of bank accounts, etc. are satisfactorily redressed.
- SCSB shall be liable for all its omissions and commissions in discharging responsibilities in the ASBA process.

- ASBA Application Form without the stamp of the SCSB.
- Application by any person outside India if not in compliance with applicable foreign and Indian laws.

- Duly certified Power of Attorney, if applicable, not submitted alongwith the ASBA application form.
- No corresponding records available with the Depositories matching the parameters namely (a) Names of the ASBA applicants (including the order of names of joint holders) (b) DP ID (c) Beneficiary account number or any other relevant details pertaining to the Depository Account.
- Insufficient funds in the investor's account.
- Application accepted by SCSB and not uploaded on/with the Exchange / Registrar.
